**Application Administrative Fees**

Residential Development: \$35.00 per unit, minimum fee of \$100.00.

Commercial Development: \$0.01 per square foot, minimum fee of \$100.00.

**Review Fees**

The applicant is required to post an escrow deposit with the authority in the following amounts.

Preliminary Plan Review:

Residential Development: \$35.00 per unit or a minimum fee of \$250.00, whichever is greater.

Commercial Development: \$0.05 per square foot of commercial building area or a minimum fee of \$250.00, whichever is greater.

Tentative Plan Review:

Residential Development: 3% of the estimated project cost or a minimum fee of \$500.00, which ever is greater.

Commercial Development: \$0.15 per square foot of commercial building area or a minimum fee of \$500.00, whichever is greater.

Final Plan Review:

Residential Development: 50% of preliminary review fee escrow deposits or a minimum fee of \$500.00, whichever is greater.

Commercial Development. 50% of preliminary review fee escrow deposits or a minimum fee of \$500.00, whichever is greater.
